

The Discounted Resits Terms and Conditions

- We (CBLA) are pleased to make the Discounted Resits Campaign (**Campaign**) available to select candidates as set out below. The Campaign is subject to the terms and conditions below, the OET Test Regulations (available at <https://www.occupationalenglishtest.org/test-regulations/>), and the Website Terms and Conditions (available at <https://www.occupationalenglishtest.org/terms-conditions/>).
- The Campaign commences on 15 April 2019 and ends on a date to be determined and announced by CBLA on its website at www.occupationalenglishtest.org (**Closing Date**) (collectively the **Campaign Dates**), and is open to candidates who have sat the OET since 15 September 2018, and failed to receive 4 Bs (**Eligible Candidates**).
- During the Campaign Dates, Eligible Candidates may enrol to resit the OET being held at venues in Australia and New Zealand up to and including the any tests on or before the Closing Date (**Eligible Resits**).
- Eligible Candidates enrolling in an Eligible Resit will be offered up to three discounted resits of the OET at AU\$350 (excl. GST) (**Discounted Resits**).
- All Discounted Resits of OET must be taken on test dates up to and, if applicable, including the Closing Date.
- For Discounted Resits, each Eligible Candidate will be asked to nominate their choice of two preferred test venues. In the unlikely event that both venues are unavailable, we will contact the Eligible Candidate to discuss their options.
- In the event an Eligible Candidate is unable to sit the OET on their scheduled test date, the Eligible Candidate will be permitted to defer their test date to another date.
- If an Eligible Candidate wishes to defer their test date, the normal [regulations and fees](#) pertaining to deferrals will apply, subject to the remainder of these terms. If an Eligible Candidate opts to defer a resit to a test date outside of the Campaign Dates, they will need to pay either the full fee or, if payment has already been made, the difference between the Discounted Resits fee and the regular advertised OET fee, in addition to the deferral fee.
- We are under no obligation to consider or accept withdrawal requests in respect of applications made under the Campaign.
- Payment and application for Discounted Resits must be received by CBLA by the relevant due date (as set out at the end of these Terms). If payment is received after this time, the Eligible Candidate's Discounted Resit application will automatically be moved to the next available test date. If the next available test is outside of the Campaign Dates, the Discounted Resit fee will no longer apply and the Eligible Candidate will need to pay either the full test fee or, if payment has already been made, the difference between the Discounted Resit fee and the regular advertised OET fee. To the extent permitted by law and subject to the OET Test Regulations, we will not provide a refund of any original payment in these circumstances.

- Where additional payment is required in accordance with these terms, if such additional payment is not made within 5 days of notice from us requiring the additional payment and in any event by the relevant payment due date (as set out at the end of these Terms), we reserve the right to cancel your Discounted Resit application. Where an Eligible Candidate defers their test date to a date outside of the Campaign Dates, and that Eligible Candidate does not pay the additional payment in accordance with these terms, within 5 days of notice from us requiring the additional payment and in any event by the relevant payment due date, we reserve the right to refuse that deferral or cancel that candidate's application. To the extent permitted by law and subject to the OET Test Regulations, we will not provide a refund of any original payment in these circumstances.
- Candidates must complete and supply all required documentation and information requested by us as part of the Campaign application process, including the Eligible Candidate unique ID. Otherwise we will reject the application and request that it is completed and resubmitted with all required documentation and information requested by us to be able to process the application.
- CBLA reserves its rights not to accept any application that does not comply with these terms and conditions.
- CBLA reserves the right to end the Campaign at its discretion, by providing notice on the OET website (**Notification**). In all instances CBLA will honour valid applications made and accepted before the Notification was provided.
