CBLA Terms & conditions

Application phase

CBLA Hero application terms and conditions 20/21

1. CBLA will only accept applications submitted online.
2. Applicants MUST be a qualified Healthcare worker in their home country.
3. Applications MUST be aged 23 years and over.
4. You (being The Applicant) must complete all parts of the application and provide answers that are accurate and truthful. CBLA will reject any application that is not completed by you or that has been completed and/or submitted on your behalf.
5. By applying for this campaign you acknowledge that you are NOT employed by, contracted to CBLA (or its affiliates) or otherwise associated with any news or media associations, including web-based businesses, anywhere in the world.
6. Applications will also not be accepted if you are related to or otherwise closely associated to or with CBLA (including, but not limited to, being employed or contracted by CBLA or you are immediately related to someone that is employed or contracted by CBLA).
7. You should not contact CBLA regarding the status of your application. CBLA will be in direct contact with you (using details you have provided in your application) if you are successful in being selected for the next round of casting.
8. Your submission of your application is not an offer or any representation that you will be considered to or will appear in the campaign.
9. The selection of applicants for the CBLA Hero campaign will be made at the sole discretion of CBLA. CBLA will not engage in any correspondence in relation to their selection of applicants.
10. You must ensure that you are in good physical and mental health and be able to prove that there is no medical, psychological or additional condition, injury or illness that could affect or hinder your participation in the campaign.

11. You hereby acknowledge that:

(a) you are aware of the potential risks associated with participating in the Campaign and acknowledge that there is the potential for it to be both physically and emotionally demanding; and

(b) If any of the information you give in the application form is false, inaccurate or incomplete, CBLA will be entitled to exclude you from the participant selection process for the Campaign.

12. You hereby warrant and represent that:

(a) you are not a user of any illegal drugs or substances; and

(b) you will answer all of the questions in the application form fully, honestly and accurately and you confirm that you have not misled or attempted to mislead CBLA in any way as to your identity or experiences in any other way.

13. If you are selected by CBLA as part of the application process, to proceed with casting for the campaign you must agree to:

(a) provide all information required for the purposes of conducting the assessments or testing referred to in paragraph (a) above;

(c) execute and deliver to CBLA all documents (including, release forms, confidentiality agreements, consents to police checks and other agreements relating to your participation in casting or the Campaign) in the form required by CBLA;

(d) make yourself available for production and promotion of the Campaign at times, dates and locations required by CBLA.

(e) provide CBLA with such information and documentation as is necessary to enable CBLA to make such enquiries as CBLA requires to confirm your identity, age, background, criminal or health record;

(f) participate in filming of the Campaign on a 24-hour 7 day a week basis during filming periods nominated by CBLA; and

(g) when engaging in such participation, interact with other participants in the Campaign and comply with CBLA reasonable directions from time to time.

14. In consideration for being considered by CBLA in the selection process for the Campaign you:

(a) agree that any footage recorded by yourself and CBLA the casting process may be used by CBLA or its licensees in the Campaign and CBLA and its licensees may exploit the Campaign throughout the world in perpetuity on all media platforms.

(b) acknowledge CBLA may edit or adapt such footage in any way it sees fit;

(c) consent to CBLA and its licensees exploiting your voice, name, image, likeness, acts or omissions and any materials or information collected by CBLA through the casting process for the purpose of producing and exploiting the Campaign throughout the world in perpetuity in all media.

15. At this time we will not be accepting any applicants from IRAN

16. You acknowledge that all information and matters relating to the application process, and your participation in it must be kept confidential. All information that you obtain about the casting process, the Campaign and its production, publicity and exploitation and the businesses of CBLA and its licensees is for the purposes of these terms and conditions, Confidential Information.

17. Except as otherwise required by applicable law, you must:

(a) Keep all CBLA Confidential Information confidential;

(b) not use the Confidential Information for any purpose other than the purpose of your participation in the casting process; and

(c) except with CBLA's prior written consent which may be withheld in CBLA's absolute discretion not disclose the Confidential Information to any other person.

18. Without limiting paragraph 16, you must not make any statement or give any interview about your participation in the casting process via any platform (including via any media outlet or any social media platform).

19. To the maximum extent permitted by law, You hereby discharge, waive, and release CBLA, its employees, contractors and licensees from any claims, demands or liability of any kind whatsoever, including without limitation, those grounded upon alleged violation of, or interference with, privacy, any accident, illness or injury, or in respect of any footage/recording made of you, or arising in connection with your participation in the casting for and/or production of the Campaign (including in relation to the use of any materials provided by me in the Campaign). Without limiting the foregoing and to the maximum extent permitted by law, I agree that my remedies in relation to my participation casting for and/or production of the Campaign are limited to the right to recover damages at law and CBLA's cumulative aggregate liability to me in relation to my participation in the casting for and/or production of the Campaign will not exceed \$1,000.

20. CBLA reserves the right to terminate or extend campaign at any given time.

21. Applications close 30 January 2021 – CBLA reserves the right to extend this date at any time.

22. These Terms and Conditions are governed by the laws of Victoria, Australia.

Video Technical Requirements

- You only need to upload ONE video
- Your video should NOT be longer than 60 seconds. (One minute Maximum)
- Ensure there is good lighting while recording your video
- Ensure there is NO external noise while recording – just your voice
- The maximum file size for uploaded video files is 500mb. If your file is larger than this you can compress your video using free video compression software. One you may like to consider is <https://www.macroplant.com/adapter/>
- Please be patient when uploading your video, as there are a number of factors that will determine how quickly your upload will occur (your internet access speed, size of video). We recommend using either FireFox or Google Chrome browsers as they are best at handling large file uploads. You can download Chrome for free here <https://www.google.com/chrome/>
- Please turn OFF all popup blockers and Ad Blockers
